b. Discussion and Action of Private Well at 100 Boyson Rd

### Minutes:

100 Boyson Rd development is requesting to install a private well to fill retention basin to be used for irrigation and possible fountain for beautification. The Water Department Rules and Regulations Section 16.c -Section 1 states: No private well shall be installed where a public water supply is reasonable accessible. City Attorney, Mark Parmenter advised that city code 90.03 conflicts with the rules and regulations for the water department by stating that only wells with potable or drinking water are not allowed. This currently allows for wells for irrigation or fountains. The Water Board decided to allow 100 Boyson Rd development to go forward with their plans for their well with the agreement that they will install a backflow prevention device that will be regularly tested, and access to the well will be provided to the water department for regular testing. Marty will meet with Mark at a future date to look at standardizing the wording of the city code and rules and regulations.

## Minutes:

The CDBG application submitted was not approved for funding. We will reapply again. Shive Hattery Engineering is looking to go out for bids fall 2023 to begin work spring 2024. The Water Department had a water main break May 18th on Blairsferry Rd between 6th and 7th Ave. Another water main break occurred May 30th on Northwood Dr, near 103 Northwood. While exercising valves on June 13th, a valve began to leak at the corner of 8th Ave and Blairsferry Rd.
