f. Discussion of Robins Rd Water Main Replacement Project

Marty informed the board of this upcoming project in conjunction with the City's Storm Water and Sewer project in the area on Robins Rd. from South of Boyson Rd to Pirie Dr. The water main in this area is deep and has had many main breaks. City Engineering is looking into multiple funding options for this project. We were unable to present a resolution for the Engineering cost this month. We asked the board to make a motion for approval and the official Resolution will be presented in June.

Robert Rampulla made a motion to go forward with Engineering cost estimate of \$188,400.00 from Shive Hattery for the Robins Rd Water Main Replacement Project. Resolution to be presented at the June Water Board meeting. Patrick White seconded. Motion carried.
