1. Call to Order

Minutes:

Meeting was called to order at 5:30 PM by Chairperson Carl Ransford in the Council Chambers. Member's present were Patrick White, Ruth Hospodarsky and Mike Nesslage. Absent was Troy Andersen. Also present was Council Liaison Steve Dodson, Water Superintendent Marty Recker and Water Clerk II Sara Ries. Roll was called.

3. Approval of Agenda

Minutes:

a. Consider Resolution Authorizing Final Payment for the Boyson Rd Water
Treatment Plant Backwash Tank 2021

Minutes:

Final payment of \$39,292.50 to Boomerang Corp. will be paid by the City from LOST funds.

Ruth Hospodarsky made a motion to pass Resolution 15-2022 Authorizing Final Payment for the Boyson Road Water Treatment Plant Backwash Tank 2021. Mike Nesslage seconded the motion. b. Discussion of Watermain Repair at Daws Rd., Thiher Dr. & Clymer Rd.

Minutes:

Marty explained that Clymer Rd, Daws Rd and Thiher Dr are being considered for replacement as part of the Robins Rd watermain project. The City may be eligible for CDBG funding with the addition of this area. Currently the City has obtained ARPA Funding for the Robins Rd portion of this project and are working on reapplying for more funding. With the addition of the Clymer, Daws and Thiher, which are in need of updating as this area is served with a 4" watermain that doesn't meet the DNR requirement for fire protection, the City's eligibility to receive CDBG funding is much greater due to the LMI (low to moderate income) in this area. The 4" watermain on these streets would be replaced with an 8" watermain and help with the water systems loop. Recker recommends we move forward with this project. The Water Board agrees but, would like to see what the final numbers from the Engineers show in September.

6. Superintendents Report

Minutes:

We welcomed Mike Nesslage as the newest Water Board member.

Marty spoke to the board about the high service pumps at 2030 Boyson Rd. needing to be serviced. The pumps have 10 years on them and over 11,000 hours. He will be contacting the supplier to have some preventative maintenance done on them to prevent any possible delays in our water production.
