Scope

Audiomatrix will supply and install the equipment mentioned in this quote. We will reuse the existing cabinets, speakers, touch screen and the existing wireless microphone systems along with some wiring. We understand that we cannot put more holes into the countertops and will need to use existing holes. The microphones will be placed on the countertops and we will setup for the additional 3 microphones. The microphones will feed the DSP which will then feed the amplifier. The existing wiring to the speakers we be tied into the new amplifier. The audio system will be controlled via the new control system for muting and volume control.

The projectors will be replaced with new 86 inch TVs. One of the reason for the upgrade was to allow for HD video, these TVs are capable to ensure your problem is solved. We will offer three plug points for video at the current locations. These plug points will offer HDMI and VGA. Both signals will carry audio back thru the system. Along with the three plug points the system will also offer wireless video connection. This device will sit on your network. The TVs will also be controlled from the control system. The control system will be placed on an IPAD but also on a hardwired touch plate back in the control room. This will help ensure your system doesn't crash if you lose the IPAD. Audiomatrix will install a TV in the lobby and wire that TV into the system so that digital signage or the meetings can be displayed on it.

Client's existing document camera will be wired into the new system via its VGA connection. Client's existing confidence monitor will be replaced with a new 65 inch monitor. The system will feed video out to the confidence monitor.

The system will be capable of routing different video signals in different directions. You will have the option of routing the three plug points (treated as one source) to either the streaming end point, projectors, lobby TV or combinations of them. The same will be true for the digital signage along with the same being true for the wireless video presentation option. You will also have one more open input at the control room.

The three existing cameras will be replaced with new 1080P cameras. These cameras will feed back to the Vaddio controller which will feed the existing touch monitor and H.264 encoder. We will also feed the video plug points into the Vaddio controller.

This quote assumes that client will be suppling computer that we can configure the H.264 encoder for. The encoder requires USB 2.0 connection. The computer will then be loaded with OBS software or software of client's choosing. Audiomatrix can supply computer if client requests for an additional fee.

The system carries a 1 year labor warranty along with a 1 year warranty on equipment from Audiomatrix. The labor warranty includes labor on site and travel to site along with any freight needed for support. The manufacture carries their own warranty on the equipment. Please see below for a break down on some of those items.

Audiomatrix will remove and recycle any old equipment that client wants us to remove as part of this system.
