APPOINTMENTS

Board of Adjustment—Mike Shaw, Filling Unexpired Term

Moved by Councilor Tate, seconded by Councilor Shalata to appoint Mike Shaw to the Board of Adjustment to fill an unexpired term. Upon roll call the following voted in favor: Councilors Halter, Zotti, Shalata, and Tate. Motion carried unanimously.

PETITIONS

Councilor Tate stated that Warren Anderson sent in a comment regarding the water break on Dewar Drive. Mayor Kaumo addressed this comment, stating that he spoke with Heather Anderson regarding the water line break right next to Panchos. He added that the core is on the northerly, Killpecker side. There is one line and it forks off to the businesses. Yesterday, the lines were exposed, and it was discovered that 5 businesses are tied into the line. Not being able to fix the line running across Dewar Drive, and having WYDOT involved and closing roadways complicates the project. Mayor Kaumo stated that it is not a City of Rock Springs project, and the responsibility lies with the property owners. The bore pit is exposed at both ends of the lines, so the project must be completed soon. Boring is much less expensive than cutting out concrete. The concern is the cost between all 5 businesses to repair the line. Rick Beckwith, City Attorney, stated that ordinance suggests that individual users have their own service line insurance in order to be protected when tapping into the City's main line. The portion on the main roadway would be the responsibility of the City. Mayor Kaumo asked if there were any other petitions at this time.

Senator Tom James addressed the Governing Body as a citizen, wishing to discuss the lot on Blue Sage. He asked what would be done with the lot now that no bids were sent in. He sent Councilor Zotti an email regarding the appraisal that was done by his chosen appraisal company, compared to the appraisal that was done by the City's appraiser. Mayor Kaumo stated that the appraisal was received, and that he was alarmed by the difference between the two appraisals. He asked if Mr. James was interested in placing an offer on the property. Mr. Beckwith stated that the same process must be followed as before, obtaining a third party appraisal and that an offer could not be tendered at this time without an appraisal from a third party. Mr. James stated that it must be a realistic price. Mayor Kaumo stated that the appraisal received from Mr. James was priced at \$16,000, and the City's minimum bid was set at \$25,000. Mayor Kaumo stated that the Council will discuss accepting a lower minimum bid, and that he is concerned at the stark difference between the two appraisals. Councilor Zotti summarized how the appraisal was calculated with the City's chosen appraiser. The differences between the two appraisals and how they were performed were discussed. Mr. Beckwith reiterated that a third party appraiser is needed at this point. Mayor Kaumo added that the City is struggling to find appraisers to look at properties, and if the Council is agreeable, the discussion can take place to plan for a reappraisal. A comparison of both appraisals can be done. Mr. James requested that the appraiser chosen be required to abide by the standard procedures performed by appraisers. Mr. James asked if this appraiser has been used by the City before, to which Mayor Kaumo replied that they have not. Paul Rock is usually who the City hires for appraisals, but he was very busy. Discussion took place regarding the price and liabilities that are present after a bid is placed. Mayor Kaumo requested that Mr. James email with more information, and in the meantime the City will do its due diligence to research the issue. Discussion took place regarding selling this property while remaining cognizant of the accountability to taxpayers.
