A RESOLUTION ACCEPTING THE ASSIGNMENT OF RIGHTS TO AFGHAN PATTERNS FOR AFGHANS SOLD AT THE ROCK SPRINGS HISTORICAL MUSEUM.

WHEREAS, the Rock Springs Historical Museum sells afghans that are supplied by Sue Porter and Jo Mahaffey d/b/a J&S Enterprises; and,

WHEREAS, the afghans supplied to the museum are characterized by unique patterns that are specific to the City of Rock Springs, the Town of Superior, and Coal Camp Reunion; and,

WHEREAS, J&S Enterprises will no longer be supplying afghans to the museum, but have assigned the unique patterns to the City of Rock Springs so that afghans can be directly ordered from the manufacturer; and,

WHEREAS, the Governing Body of the City of Rock Springs has reviewed the assignment of patterns from J&S Enterprises, and finds that it is in the interests of the City to acquire the rights to said patterns.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ROCK SPRINGS, STATE OF WYOMING:

Section 1. That the assignment of afghan patterns from J&S Enterprises to the City of Rock Springs, attached hereto and by this reference specifically made a part hereof, is hereby accepted by the City of Rock Springs.

If further assistance is required to complete the assignment and transfer of the afghan designs to Museum, the undersigned agree to assist in any manner required in the future.
