PRESENTATIONS AND PROCLAMATIONS

To Write Love on Her Arms 7th Annual Run For It 5K—Danielle Thompson

Danielle Thompson addressed the Governing Body and stated that she supports an organization called To Write Love on Her Arms, an organization dedicated to suicide prevention and mental

health support. To Write Love on Her Arms has donated \$2.3 million to suicide prevention. A 5K has been started to bring awareness and spread hope to those struggling with mental awareness. This is the third year for the race in Sweetwater County. Ms. Thompson's brother died by suicide in 2013 and depression, PTSD and anxiety drove him to take his own life. Many people struggle with depression or anxiety. Johns Hopkins University estimates that 26% of Americans 18 and older suffer from a diagnosable disorder in any given year, which are just reported cases. Many do not have health insurance or the funds to seek assistance. To Write Love on Her Arms is dedicated to helping dismantle the stigma associated with mental illness and help people with funding to seek mental health assistance. On April 13, 2019, there will be a Run For It 5K at Western Wyoming Community College, to sign up please follow this link: https://give.twloha.com/team/216377. Mayor Kaumo commended Ms. Thompson for her efforts and encouraged citizens to create teams and participate in the 5K taking place on April 13, 2019.

Boys & Girls Club Week—April 8-12, 2019

Mayor Kaumo proclaimed the week of April 8-12, 2019, as Boys & Girls Club Week in the city of Rock Springs, and encouraged all citizens to join him in recognizing and commending Boys & Girls Clubs in Wyoming for providing the young people of our communities with comprehensive and effective youth development services.

Councilor Wendorf thanked the Boys and Girls Club for their ongoing help with the annual City-Wide Cleanup. Mayor Kaumo stated that he had a complaint yesterday regarding high school students throwing garbage out of their windows and onto the railroad area. He stated that we would be happy to be sure to pay attention to the area during City-Wide Cleanup. The garbage was cleaned up the next day, and Councilor Wendorf added that City-Wide Cleanup will take place on May 18, 2019.

Sarcoidosis Awareness Month—April 2019

Mayor Kaumo proclaimed the month of April, 2019, as Sarcoidosis Awareness Month in the city of Rock Springs, and called upon all citizens, medical facilities, and businesses to increase their awareness of Sarcoidosis and to consider supporting research efforts to aid in finding a cure and improving treatment for this rare disease. He added that the city will be lit up with purple to bring awareness on Saturday, April 13, 2019.

Jennifer Cash addressed the Governing Body and stated that she drove 7.5 hours to be here, and that she was misdiagnosed with lung cancer, to find out later that she has Sarcoidosis. 60% of Sarcoidosis sufferers have it temporarily, and 40% have it permanently. Ms. Cash has this condition permanently. She is an ambassador from Frannie, Wyoming and her goal is to spread awareness of Sarcoidosis, and there are many patients who have been diagnosed, just in Wyoming. Mayor Kaumo commended her for her efforts and thanked her for coming tonight to accept this proclamation. Ms. Cash asked if we would send photos of the purple lighting throughout our City to be broadcast nationally.

Sexual Assault Awareness Month—April 2019

Mayor Kaumo proclaimed the month of April, 2019, as Sexual Assault Awareness Month in the city of Rock Springs, and commended the observance of all citizens, by urging each to learn what

can be done to combat sexual violence, and to offer prevention measures and support and services to survivors. He added that teal bracelets will be available throughout the community to wear in support of awareness of sexual assault during the month of April and the Sexual Assault Awareness Run/Walk with the Badges will be held on April 27, 2019, 8 a.m. at the Family Recreation Center in Rock Springs, Wyoming.

Melinda Baas, Director of the YWCA addressed the Governing Body and stated that there is a 5% rate of rape that has not changed in years. Two thirds of assaults are committed by someone a victim knows. Ms. Baas stated that bringing awareness and campaigning prevention for sexual assault is the first step and has such a powerful effect on changing behavior. Teal is the color associated with Sexual Assault Awareness. Ms. Baas reiterated that there will be a Run/Walk with the Badges 5K on April 27, 2019 at 8 a.m. at the Family Recreation Center.

Parks & Recreation Advisory Board Meeting Minutes of February 14, 2019

Main Street Board Meeting Minutes of March 11, 2019

Councilor Wendorf added that Chief Wamsley and she attended the Airport Board Retreat, which was very informative. She also stated that the City-Wide Cleanup is on May 18 and that she has ordered 3,500 orange plastic bags from WYDOT and with the Rodeo coming into town this summer, it is a perfect time to clean up our City and make a good impression.

Councilor West added that the Specific Purpose Tax Joint Powers Board has recently met and that the audit should be completed this month. All funds have been sent to the County treasurer and should be disbursed, which totals \$6.1 million in funds. Of that portion, Rock Springs is set to receive \$2,975,121.67. Debate regarding House Bill 95 has taken place regarding how excess funds can be expended. Councilor West included information from the original bill regarding how funds should be expended. Mayor Kaumo stated that the City Attorney has researched the information and that the intent of House Bill 95 is to allow the municipalities to decide how to use the funds, not necessarily for the stated Operation & Maintenance purposes. City Attorney Rick Beckwith stated that he recently drafted Memo regarding his research for the City's authority to disburse excess tax funds from the excise tax and what can be done with the funds. The change in the statute will become effective July 1, 2019. The Resolution from the County states that the excess funds will be used for construction to existing projects. Each City passed its own Resolution for the original funds, and which none address excess funds. All City Resolutions refer to an Exhibit A to their Resolutions, which Exhibit A should be Sweetwater County's Resolution. In reviewing City of Rock Springs records, Exhibit A was not attached to the City's Resolution. Mr. Beckwith stated that he did not review records of any other municipality, but stated that the argument could be made that we are bound by the County's Resolution, since it was referenced; however, not attached. Since Exhibit A was not attached, the Governing Body did not take Exhibit A into consideration when passing the Resolution, which could be argued that the City's Resolution did not address excess funds. Mayor Kaumo added

that the full intent of House Bill 95 was to allow municipalities to use the funds as they deem fit, so with projects coming up, it will be important to review this and discuss it.

Moved by Councilor Wendorf, seconded by Councilor Demas to approve the Council Committee and Board Reports and place them on file. Motion carried unanimously.
